**Other Uses:**

HEERF II allows for defraying expenses associated with coronavirus (including lost revenue, reimbursement for expenses already incurred, technology costs associated with a transition to distance education, faculty and staff trainings and payroll.) Goucher College is a residential college with approximately 85% of undergraduate students living on campus. Due to the coronavirus, Goucher College transitioned to online instruction beginning March 2020 and through fiscal year 2021, with housing available on campus in a very limited capacity (with approximately 50 students through Mid March and approximately 150 in April and May.) As a result, room and board revenue was significantly diminished in FY 21. Board revenue funds the costs of food service, paid to our provider Bon Appetit. For the quarter 3/31/21, Goucher College utilized HEERF II funds to reimburse us for \$600,000 paid to Bon Appetit for food service. This represented expenses paid to Bon Appetit in excess of total Board Revenue charged to students in FY 21.
