APPLICATION FOR ADMISSION

Admission to the limited-residency Master of Arts in Historic Preservation program is granted to selected applicants whose academic and personal qualifications give promise of success in self-directed graduate study. The applicant must hold a bachelor's degree from an accredited college or university and have a minimum of two years paid or volunteer post-baccalaureate work experience. All application materials are due February 19, 2010. Letters of acceptance will be mailed March 12, 2010.

Application Checklist

To be considered for admission, an applicant must submit the following by February 19, 2010:

- A completed application form, including three copies of the essay and a nonrefundable \$50 application fee made payable to Goucher College.
- Official transcripts of all undergraduate and graduate work sent directly by the institution to the Master of Arts in Historic Preservation, Welch Center for Graduate and Professional Studies, Goucher College, or by including official transcripts in the institution's sealed envelope with your application.
- Three letters of recommendation from people who know you well enough to give an informed opinion of your intellectual ability, capacity for sustained self-directed study and personal qualifications.
