Engineering Control Equipment

The following areas have Engineering Control Equipment to eliminate or minimize employees' exposure to bloodborne pathogens:

Athletic Department	Handwashing facilities
Science departments	Sharps disposal containers; red trash bags [for collecting pipettes]
