

2022-2023 - Post-Bac Pre-Med (PBPM) Borrowing Scenarios

Please note that optional health insurance available through Goucher is ***not included*** in these estimates.

Plan A: Borrowing \$20,500 in [Federal Unsubsidized loans](#)

This plan is designed to cover your billable costs for the Summer 2022 term, making Fall 2022 the first term where you need to make additional payment arrangements. **A valid FAFSA needs to be on file for federal loans.**

Summer 2022	\$9,888 (-\$500 deposit)	\$9,488	No payment due	Paid out-of-pocket

Spring 2023	\$17,304	\$5,506	\$11,857 (due 1/16/2023)	Paid out-of-pocket

To cover all billable costs, apply for ***at least*** a \$23,472 Graduate PLUS or private loan by no later than June 7 2022.

Plan B: Maximum Borrowing - \$20,500 in [Unsubsidized](#) and \$43,180 in [Grad PLUS loans](#)

For students who need to borrow to help with indirect costs such as books and living expenses. Funds you are borrowing are paid to you as a “refund” issued by the billing office after the loans are applied to your account. See estimated dates below.
