FINANCIAL RESULTS FOR FISCAL YEAR 2019-20

The pandemic has brought with it financially challenging times for the higher education industry. In this moment, Goucher College is more thankful than ever for the philanthropic support shown by our donors who have invested in Goucher in the past and built our endowment. Goucher leaned heavily on this philanthropic support in fiscal year 2020, as we successfully navigated many financial challenges.

From the start of this pandemic, we made it very clear that at Goucher, the safety of our students, faculty, and staff comes first, and that we would rely upon the very best public health advice and science to guide our decisions. On March 14, 2020, the college transitioned to remote education. This put a significant strain on the college's revenues, as we credited students' accounts for 50% of their spring semester's room and board charges, approximately \$3.5 million.

Families nationwide continue to struggle to find the means necessary to pay for college. In fiscal year 2020, the college provided over \$39 million in scholarships and financial aid to help make the dream of a Goucher education possible for our students. However, this is a delicate balancing act, as the college remains dependent on student revenues (tuition, room, and board), representing 59% of total revenues. Overall, student revenues decreased by 12% as a result of closing the residence halls and providing additional student financial aid.

Across campus, we rose to the challenge and worked together to manage expenses to respond to the decline in student revenues, cutting expenses over 6% from the previous year.


Our donors responded, too! Endowment giving was at its highest levels since 2014, as donors continue to invest in the future of Goucher. Six new scholarships/fellowships were created as our community rallied to address access and affordability. For that, we are grateful. The college's endowment, a collection of investments made possible by our generous donors, stands tall at \$191 million, representing nearly half of the college's total assets on June 30, 2020. These investments provide annual support for the college and our students. In fact, 34% of the college's revenues in fiscal year 2020 were funded by present and past donors through a combination of contributions and endowment payout, up from 27% the previous year.

Thank you for continuing to support Goucher College and our students.



TOTAL REVENUE (\$68.4 MILLION)




For the fiscal year ending June 30, 2020

TOTAL ENDOWMENT (\$191.4 MILLION)




DONORS BY CONSTITUENCY




THE LARGE IMPACT OF GIFTS BELOW \$500
