Goucher College Poll results:

Majority support legal recreational marijuana and access to abortion; majority of Marylanders have a mostly positive view of state economic conditions; Gov. Larry Hogan maintains strong job approval rating; President Joe Biden popular, but approval rating declines; residents think Maryland is a Northern state

BALTIMORE (October 26, 2021)—The Goucher College Poll asked Maryland residents their views on various statewide issues, including the direction of the state, the current economic situation, and Gov. Larry Hogan, as well as their views on President Joe Biden and Sens. Ben Cardin and Chris Van Hollen. Residents were also asked their views on the legalization of recreational marijuana and abortion, government spending, visiting a state park, and whether Maryland was a Northern or Southern state. The Goucher College Poll surveyed 700 Maryland adults from October 14 to 20, 2021, and has a margin of error of +/-3.7 percent. Results by voter registration and other key demographics are provided.

Legalization of Recreational Marijuana, Attitudes Toward Abortion, and State Spending

Sixty percent of Maryland residents support the legalization of recreational marijuana, and **33 percent** oppose it. This represents a slight decline in support since the March 2021 poll, where **67 percent** of Marylanders supported legalization.

Most Marylanders (88 percent) want to keep abortion legal though they are divided on whether that means legal in all (44 percent) or only under certain circumstances (44 percent).

Respondents were asked whether the state government spends too little, about the right amount, or too much on several broad budgetary items.

<u>Public education</u> Too little: **54 percent** Right amount: **31 percent** Too much: **9 percent**

<u>Public transportation</u> Too little: **40 percent** Right amount: **43 percent** Too much: **9 percent**

<u>Roads and highways</u> Too little: **47 percent** Right amount: **41 percent** Too much: **8 percent**

<u>State parks</u> Too little: **27 percent** Right amount: **59 percent** Too much: **6 percent**

Housing and community development Too little: **47 percent** Right amount: **30 percent** Too much: **15 percent**

Unemployment assistance Too little: **32 percent** Right amount: **34 percent** Too much: **27 percent**

Interest in Visiting a Maryland State Park

The visitation rates to Maryland state parks have significantly increased over the past two years, according to an analysis by the Maryland Department of Natural Resources. The results of the poll indicate that **84 percent** of residents are "somewhat" (**33 percent**) or "very" (**51 percent**) interested in visiting a state park during the next year; **16 percent** are not interested in visiting.

"Skyrocketing visitation rates to Maryland state parks over the past two years have left the Department of Natural Resources struggling to meet the increased demand. Our results indicate that parks will continue to be a sought-after destination for many state residents over the next year," says Mileah Kromer, director of the Sarah T. Hughes Center for Politics at Goucher College. "But there is a pretty clear disconnect: Despite clear pressures on the park system from increased visitation, nearly sixty percent of residents think that the amount of funding that state parks receive is 'about right.""

Gov. Larry Hogan and Perceptions of Maryland

Hogan remains a popular figure in the state. Sixty-eight percent of Marylanders approve of the job Hogan is doing as governor, 22 percent disapprove, and 7 percent say they don't know.

Fifty-nine percent say Maryland is heading in the right direction, and **31 percent** say Maryland is off on the wrong track. The majority of Marylanders—**53 percent**—hold a mostly positive view of the Maryland

economy, while 37 percent hold a mostly negative view.

President Joe Biden, Sens. Chris Van Hollen and Ben Cardin

Fifty-three percent of residents approve of the job Biden is doing as president and **43 disapprove** of it. This represents a drop in approval since March 2021, when **62 percent** of residents approved of the job Biden was doing as president and **31 percent** disapproved.

Forty-four percent of Marylanders approve of the job U.S. Sen. Chris Van Hollen is doing, **26 percent** disapprove, and **29 percent** don't know. Van Hollen will be up for re-election in the 2022 cycle.

Forty-six percent of Marylanders approve of the job U.S. Sen. Ben Cardin is doing, **26 percent** disapprove, and **26 percent** don't know.

Both Cardin and Van Hollen earn majority support from registered Democrats: **62 percent** and **56 percent** approve, respectively.

Maryland: More Northern or Southern?

The question of whether Maryland is more of a Northern or Southern state is hotly debated topic. Sixty-five percent of Marylanders say it's more of a Northern state, while 27 percent say it's more of a Southern state.

Survey Methodology

To ensure all Maryland residents are represented, the poll is conducted using random digit dialing (RDD) of a county-level stratified random sample using landline and cellular telephone numbers. The sample of telephone numbers and interviewing were provided by Dynata (<u>https://www.dynata.com/</u>). The survey was conducted **October 14 to 20, 2021**. During this time, interviews were conducted from **1 to 9 p.m**.

Interviewers attempted to reach respondents with working phone numbers a maximum of five times. Only Maryland adults—residents aged 18 years or older—were eligible to participate. Interviews were not conducted with adults who were reached at business or work numbers. **Eighty-four percent** of the interviews were conducted on a cell phone and **16 percent** were conducted on a landline.

Interviews for this survey were completed with 700 Maryland adults. For a sample size of 700, there is a 95 percent probability the survey results have a +/-3.7 percentage point sampling error from the actual population distribution for any given survey question. For the sample of 631 Maryland adults identified as registered voters, there is a 95 percent probability the survey results have a +/-3.9 percentage point sampling error from the actual population for any given survey question. Margins of error are higher for subsamples. In addition to sampling error, all surveys are subject to sources of non-sampling error, including question wording effects, question order effects, and non-response bias. Margin of error is not adjusted for design effects. Data is weighted by gender, age, race, region, and educational attainment of the state to represent adult population targets established by the most recent American Community Survey (ACS) and U.S. Census.

Survey Question Design

The Goucher College Poll provides the questions as worded and the order in which they are administered to respondents.

BRACKETED ITEMS []: Items and statements in brackets are rotated to ensure respondents do not receive a set order of response options, which maintains question construction integrity by avoiding respondent agreement based on question composition.

Example: [agree or disagree] or [disagree or agree]

PROBE (p): Some questions contain a "probe" maneuver to determine a respondent's intensity of opinion/perspective. Probe techniques used in this questionnaire mainly consist of asking respondents if their responses are more intense than initially provided.

Example: Do you have a [favorable or unfavorable] opinion of President Joe Biden? **PROBE**: Would you say very favorable/unfavorable?

OPEN-ENDED: No response options are provided for an open-ended question, i.e., it is entirely up to the respondent to provide the response information. Any response options provided to the interviewer are not read to the respondent; they are only used to help reduce interviewer error and time in coding the response.

VOLUNTEER (v): Volunteer responses means the interviewer did not offer that response option in the question as read to the interviewer. Interviewers are instructed not to offer "don't know" or "refused" or "some other opinion" to the respondent, but the respondent is free to volunteer that information for the interviewer to record.
