



# ADMINISTRATOR I MASTER OF EDUCATION IN SCHOOL IMPROVEMENT LEADERSHIP

## A Cohort Designed for BCPS Teachers

The purpose of this cohort is to develop innovative leaders who demonstrate high level skills in leading change and in establishing and sustaining a positive school culture. This 39 credit master's program will focus on instructional leadership including implementation of the College and Career Readiness Standards (Common Core Standards) and Universal Design for Learning. Cohort participants will be cognizant of current thought related to cultural proficiency and school assessment topics.

During a year-long practicum, participants will apply theories and practices from course work in the school environment. This is a Maryland approved program leading to administrator 1 certification.
